IMMIGRATION

Commercial disputes

- Acting for Alitalia in dealing with cargo and passenger claims and disputes with travel agents.
- Participating in acting for a large international Italian fashion group that involved the firm dealing with a range of issues including restructuring, intellectual property, GDPR and property acquisition and disposal.

Immigration

- Advising new employees to the UK from Italy on their employment rights generally while in the UK; negotiating contracts and benefit packages; and advising on exit strategies and internal procedures.
